

## **Colorado Medicaid Waivers**

#### What is a Medicaid Waiver?

- A Medicaid Waiver is designed as an extra benefit to Health First Colorado (Medicaid) to support children, youth, or adults with disabilities allowing them to remain in their homes and communities.
- Children's Medicaid Waivers DO NOT count household income and are solely based on child's diagnosis.
- Adult Medicaid Waiver programs DO count income and require Social Security Disability eligibility; however, they also offer buy-in options in order to allow working adults with disabilities to receive services necessary to remain in their homes and communities.



#### How Does a Medicaid Waiver Work?

- A Medicaid Waiver acts as a supplemental service, meeting needs often not met by primary insurance or Health First Colorado (Medicaid).
- If you have private insurance as your Primary Insurance, Health First Colorado will typically pick up all costs not covered.
- Additional services can be provided using Waiver funding beyond Primary Insurance and Health First Colorado.



### Where Do I Start?

- Waivers are managed by either a Single Entry Point (SEP) or Community Centered Board (CCB) • List of SEP by county: hcpf.colorado.gov/community-centered-boards • List of CCB by county: hcpf.colorado.gov/single-entry-point-agencies

### **List of Children's Medicaid Waivers**

- Children with Life Limiting Illnesses (CLLI) Birth to 19 • Apply at SEP
- Children's Extensive Services (CES) Birth to 18 • Apply at CCB
- Children's Habilitation Residential Program (CHRP) Birth to 20 • Apply at CCB
- Children's Home and Community-Based Services (CHCBS) Birth to 18 • Apply at SEP, CCB, or with a Private Case Management Agency



## List of Adult Waivers

- Brain Injury Waiver (BI)
  - Apply at SEP
- Community Mental Health Supports Waiver (CMHS) • Apply at SEP
- Developmental Disabilities (DD)
  - Apply at CCB
- Elderly, Blind, and Disabled (EBD)
  - Apply at SEP
- Complementary and Integrative Health Waiver (CIH) • Apply at SEP
- Supported Living Services Waiver (SLS) • Apply at CCB





## **Commonly Needed Documentation**

- Documented medical diagnosis
- School records with documentation of evaluations and support services
- Medical documentation to justify level of care services
- Cognitive or Adaptative Behavior testing
- SSI Determination Letter or Denial Letter (Adult Waivers)



# Timeline

- New Children's Waiver eligibility determinations can take 3 6 months.
- New Adult Waiver eligibility determinations applications can take up to 9 months.
- Transition from Children's to Adult Medicaid Waivers should begin at 17 years 9 months. \*
  - Children can obtain a Developmental Disability Determination at age 14 regardless of Waiver to be placed on the DD Adult Waiver Waitlist.
  - Children can automatically transition to the Adult DD Waiver and bypass the waitlist from the CES or CHRP Waivers.

\*We recommend beginning the conversation of transition starting at 16 years old to establish a plan and timeline to gather necessary documentation
